NOTRA: Open to any Afghan Hound, Basenji, Borzoi, Cirneco dell Etna, Greyhound, Ibizan Hound, Irish Wolfhound, Italian Greyhound, Pharaoh Hound, Rhodesian Ridgeback, Saluki, Scottish Deerhound, Silken Windhound, Sloughi, Whippet or provisional breed (Portuguese Podengo and Magyar Agar) one year or older on the day of the meet.

Sprinter Racing SATURDAY ONLY for WRA ineligible whippets. DQs OK - no measuring, no registration requirement.

Division II racing will be offered! If any whippet owner's would like to run Division II please sign up at: http://www.indianawhippetclub.com/divisionII.html. Eligibility for DII requires no more than 25% (3) racing champions (WRA, NOTRA, or NAWRA) in 3 generations. WWWA will help facilitate tracking your whippet's points. More information about DII can be found at the above website.

General Rules

All racers must wear muzzles. All racers will be boxed unless the race committee deems the boxes will not accommodate a breed in attendance. Entries will only be accepted from hounds qualified to race. Hounds must be registered with the appropriate race organization to participate. To register in advance see the appropriate website (WRA: https://www.whippetracing.org; LGRA: http://www.notra.org) for more information. Registration will be offered the day of the meet; for each organization, please bring a copy of hound's registration and the \$2 registration fee. However, pre-registration is greatly appreciated by the race secretary!

Pre-Entry Fees per day: \$15 first dog, \$12 each additional dog same day; \$40 kennel fee (four dogs or more same day). Puppy races: \$10. Sprinters: \$5.

Special prizes will be awarded at the conclusion of the ASFA trial for the highest ranked hound in each breed entered in all three areas of competition:

Sprint Racing (WRA *or* LGRA) *and*Oval Racing (NOTRA) *and*Lure Coursing (ASFA)

Any hound may be entered in any event or combination of events, but only hounds that compete in all three areas of competition will be eligible for Versatility awards. To be eligible, hounds must complete all three events, without dismissal or disqualification. Hounds scratched from any event, for any reason, are ineligible for Versatility awards.

SPRINT: Each hound competing in either the WRA or the LGRA is ranked by its order of finish in the final results, relative to the other Versatility finalists.

OVAL: Each hound competing in the NOTRA is ranked by its order of finish in the final results, relative to the other Versatility finalists.

ASFA: Hounds must be entered in open, field champion or veteran stakes to be eligible for Versatility awards. Hounds entered in the singles stake are not eligible. Each hound is ranked by total score (total of prelim + final), relative to the other Versatility finalists, regardless of stake. For example:

Open stake (score):	FCH stake:	Veteran Stake:
Rank 1 dog A 303	Rank 2 dog D 299	Rank 6 dog G 292
Rank 4 dog B 297	Rank 3 dog E 298	Rank 7.5 dog H 290
Rank 5 dog C 295	Rank 7.5 dog F 290	Rank 9 dog I 285

For the tied scores, the ranks are averaged, e.g. the 7 and 8 ranks above are averaged at 7.5.

VERSATILITY: Each finalist's ranks from the three events will be summed. The hound with the LOWEST score in each breed will win the Versatility award for that breed. For example, a perfect score, earned by the highest ranked dog in each event, would be a 3.

Eligible Breeds and Registries

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

RIBBONS: 1St = Blue, 2nd = Red, 3rd = Yellow, 4th = White, NBQ = Green BOB = Purple/Gold, High Scoring Single = Navy/Gold, BIF = Red, White & Blue

PRIZES: Best of Breed & Best in Field

Regular Stakes Offered

All hounds entering Open, Veteran, or Limited stakes for the first time must include a completed certification form or waiver (all breeds) and a copy of the hound's registration certification with their entry (waived for NGA Greyhounds only).

OPEN STAKE: Any eligible sighthound that has met the certification process, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion.

VETERAN STAKE: Any eligible hounds that have met the certification process whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited Stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field. **SINGLES STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

BEST IN FIELD WILL BE OFFERED

GENERAL


- 1. All entries must be one year of age or older on the day of the trial. All first-time entries entered in Open, Veterans and Limited must have a signed Hound Certification form. As of January 1, 2003, any hound which is first-time entered in a trial, must have a copy of the hound's registration papers to send in with the entry. This is true if the hound is entering Open, Veterans, Singles, or Limited for the first time. Stakes shall be split by public random draw if the entry in any one stake is 20 or more.
- 2. In the Trial, all hounds will run twice, in trios if possible, or braces (except in the Single Stake), unless excused, dismissed, or disqualified.
- 3. Hounds not present at the time of roll call will be scratched. Each entry will be examined at inspection for breed disqualifications. Bitches in season, hounds with breed disqualifications, and lame hounds will be excused. Entry fees for hounds excused during inspection will be refunded. Spayed or neutered hounds and monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- 4. THE FIELD COMMITTEE RESERVES THE RIGHT TO BAR KNOWN AGGRESSIVE HOUNDS FROM THE TRIAL SITE.
- 5. Certifications will be offered before the trial by early entry only.
- 6. THERE WILL BE A \$5.00 FINE ASSESSED FOR ANY LOOSE HOUND NOT TAKING PART IN THE COURSE IN PROGRESS, OR FOR ANYONE NOT PICKING UP AFTER THEIR OWN DOG(S).
- 7. PLEASE BRING YOUR OWN SHADE AND WATER.
- 8. NO ONE, EXCEPT FIELD COMMITTEE, WILL BE ALLOWED ON THE FIELD WITHOUT EXPRESS PERMISSION OF THE FIELD CHAIRMAN.
- 9. Anyone exhibiting unsportsmanlike conduct will be excused from the field for

the day.
